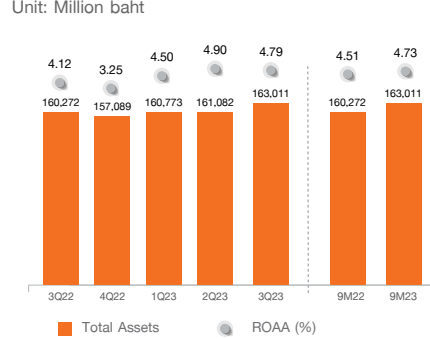
## Revenue Breakdown

Unit: Million baht



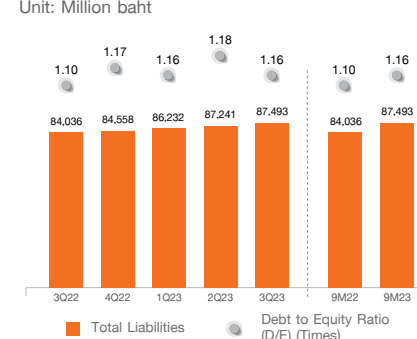
## Total Assets & ROAA

Unit: Million baht



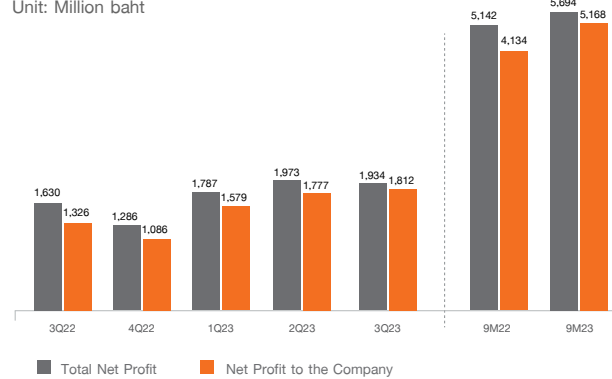
## Total Liabilities & D/E

Unit: Million baht



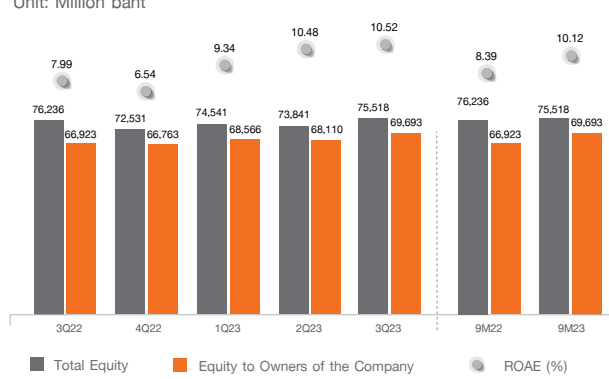
## Net Profit

Unit: Million baht



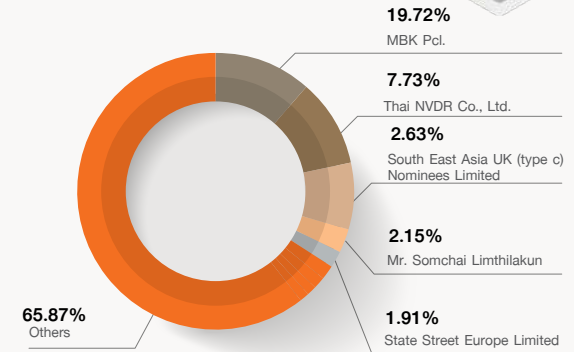
## Equity & ROAE

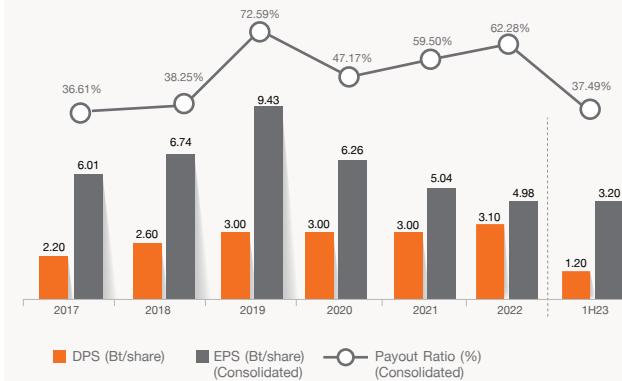


## Top 5 Shareholding

(As of 16 Oct 2023)



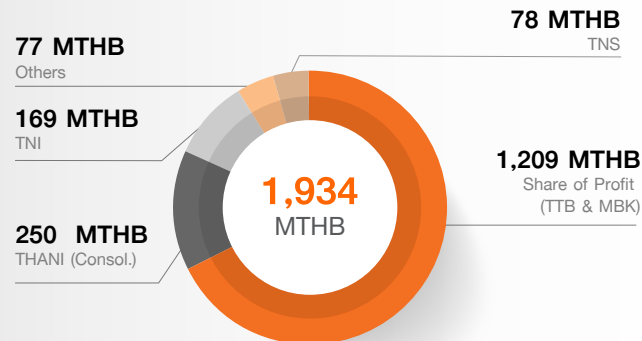

## 3Q23 & 1H23 TGROUP's Net Profit

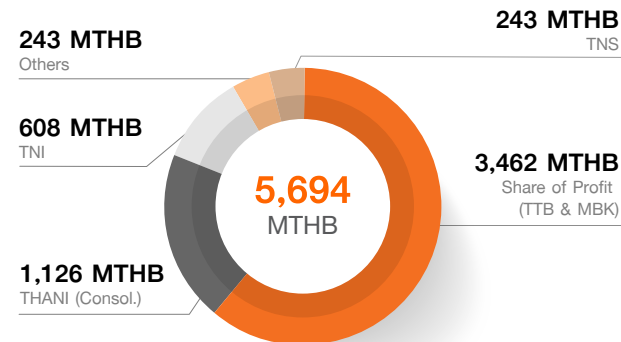
### 3Q23 TGROUP Net Profit
